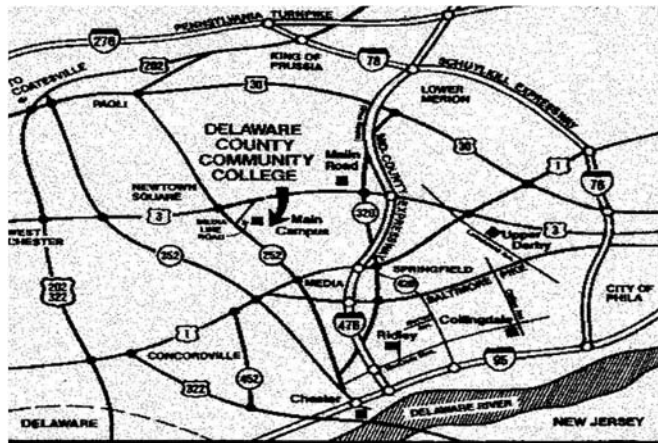

- **ALL VEHICLES ARE PROHIBITED FROM RUNNING OR REVVING ENGINES WHILE ENTERING, DURING, AND WHILE EXITING THE EVENT.**
- The police **WILL ISSUE CITATIONS** to anyone who violates the noise regulations.
